

# Fund Update for the Balanced Fund Year ended 31 March 2022

This update was first made publicly available on 30 June 2022.

### What is the purpose of this update?

This document tells you how the Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Dairy Industry Superannuation Scheme Trustee Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Balanced Fund invests in 60% growth assets (equities and real assets) and 40% income assets (fixed interest and cash). The investment objective for the Balanced Fund is to achieve average returns of 2.00% p.a. over rolling 10-year periods after tax, investment-related fees and inflation (NZ CPI).

## What are the risks of investing?

### Risk indicator for the Balanced Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



## Example of how this applies to an investor

Mary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Mary received a return after fund charges were deducted of \$58.00 (that is 0.58% of her initial \$10,000). Mary paid \$0.00 in other charges. This gives Mary a total return after tax of \$48.00 for the year.





### Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in. At 31 March 2022, the level of currency hedging for international equities was 50.5%. The level is managed between 40% and 60% and may change over time.

Other global assets classes (international fixed interest and real assets<sup>2</sup>), target a 90-110% net of tax hedge to the New Zealand dollar.
