

Fund Update for the Growth Fund Year ended 31 March 2021

This update was first made publicly available on 30 June 2021.

What is the purpose of this update?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Dairy Industry Superannuation Scheme Trustee Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Growth Fund invests in 77% growth assets (equities and real assets) and 23% income assets (fixed interest and cash). The investment objective for the Growth Fund is to achieve average returns of 3.5% p.a. over rolling 15-year periods after tax, investment-related fees and inflation (NZ CPI).

What are the risks of investing?

Risk indicator for the Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




Example of how this applies to an investor

Mary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Mary received a return after fund charges were deducted of \$2,766.00 (that is 27.66% of her initial \$10,000). Mary paid \$0.00 in other charges. This gives Mary a total return after tax of \$2,638.00 for the year.



Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in. At 31 March 2021, the level of currency hedging for international equities was 49.2%. The level is managed between 40% and 60% and may change over time.

Other global assets classes (international fixed interest and real assets³), target a 90-110% net of tax hedge to the New Zealand dollar.
